**RE: FY2015 E-rate Filing Deadline Survey of Applicants**

Dear Mr. Blackwell and Mr. Wilkins:

I am writing to you to share the results of a nationwide survey of E-rate applicants conducted by Funds For Learning. This survey was conducted March 6, 2015 through March 10, 2015. The purpose of the survey was to gain applicant insight regarding a potential change to the March 26 E-rate filing deadline.

- An overwhelming majority of applicants (89%) would welcome additional time.
- Applicants cite additional data requirements, inclement weather, and longer-than-anticipated procurement cycles as the three primary reasons for this additional time.
- The largest percentage of respondents (38%) support a two-week extension of time.

**SURVEY RESPONSES**

This is not a scientific survey, but the responses come from an extremely diverse cross-section of applicants from all across the country, of all sizes, types and geographical locations. 1.5% of applicants responded to the survey, representing schools and libraries from 52 states or territories. Over the years, Funds For Learning has conducted half a dozen national surveys of applicants. The typical response rate for our surveys is 3% to 4% of applicants. Although the response rate for this survey was lower than the norm, given the short timeframe of the survey, the timing during the filing window and the fact that responses were requested over a weekend, a 1.5% response rate seems good.

**Based on these factors, I am comfortable sharing the attached survey results as a representative sample of all applicants.**

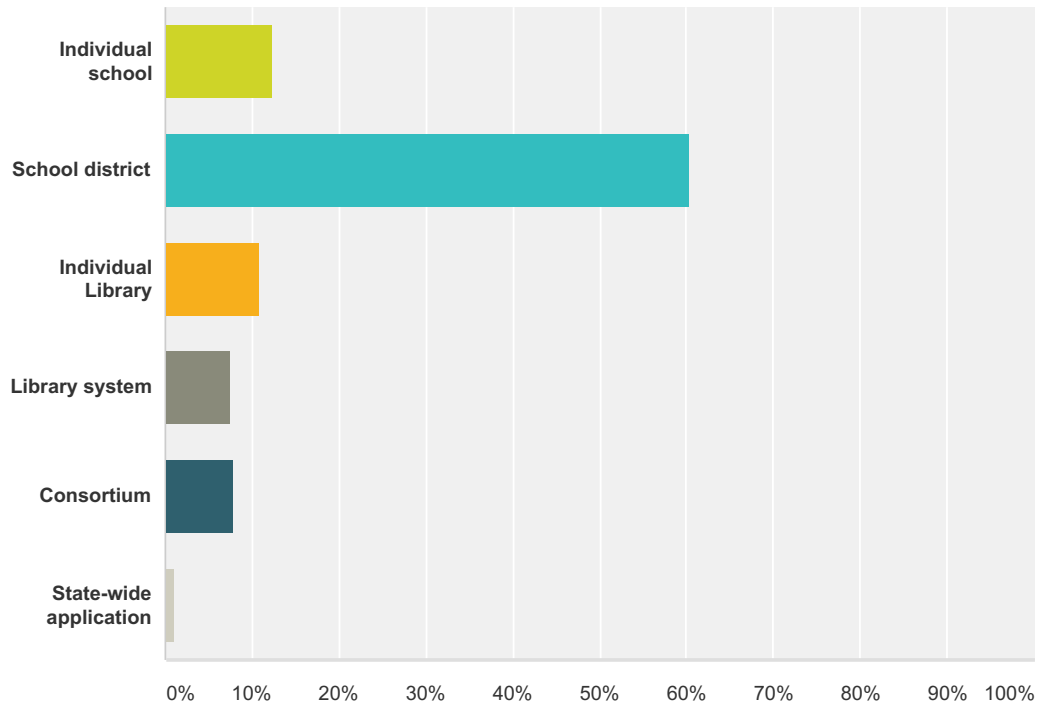

### Q1 Which entity type best describes your organization?

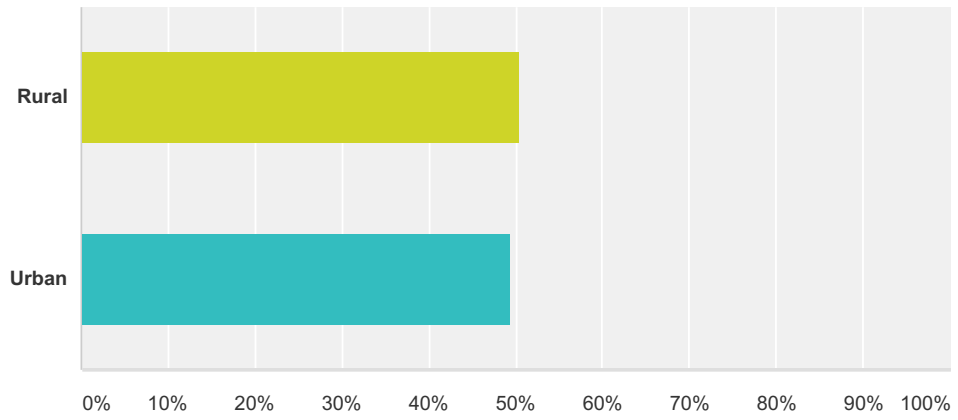

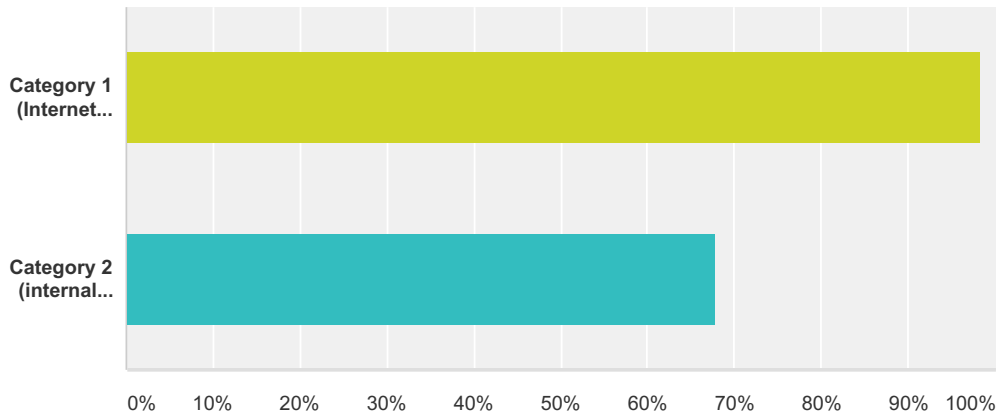

### Q6 Indicate which services you intend to request.

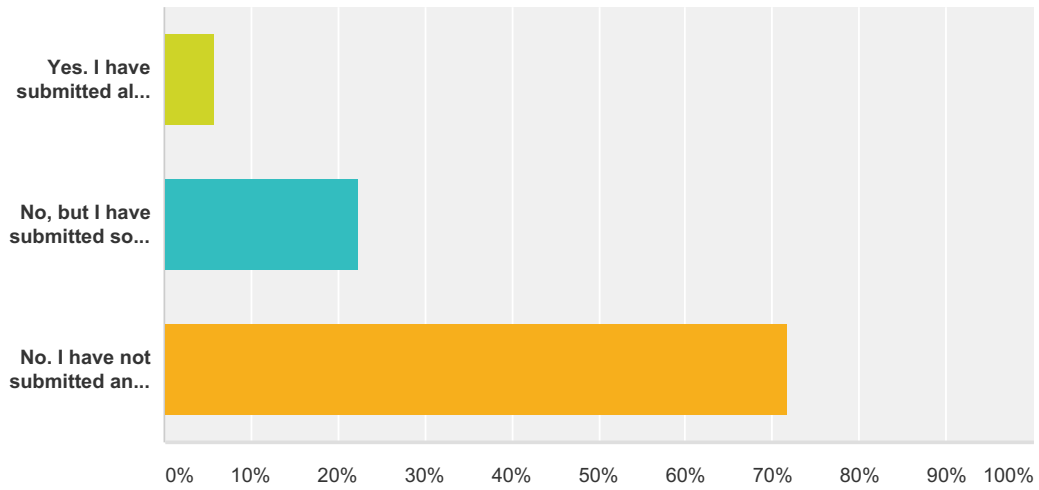

### Q7 Have you already completed and submitted all of your FY2015 applications?

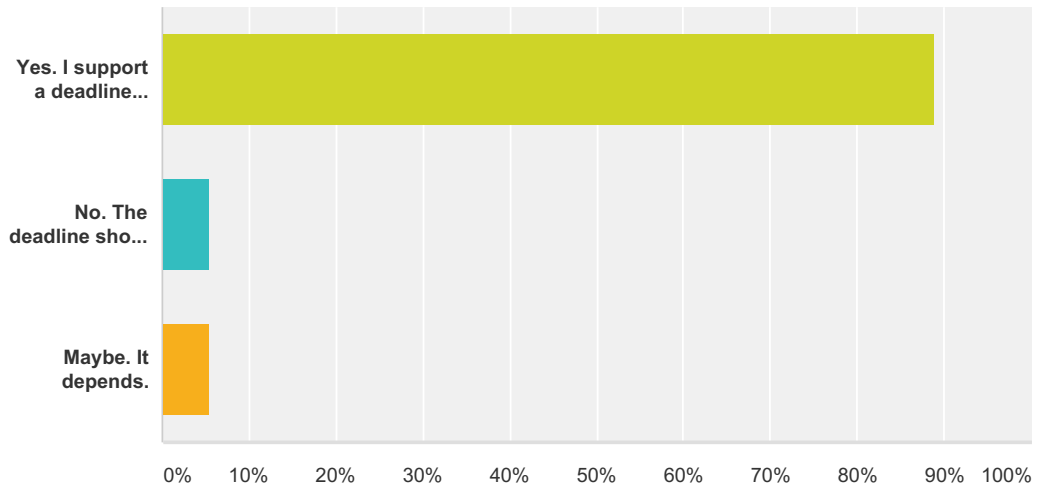

**Q8 Do you support an extension of the FY2015 filing window deadline?**

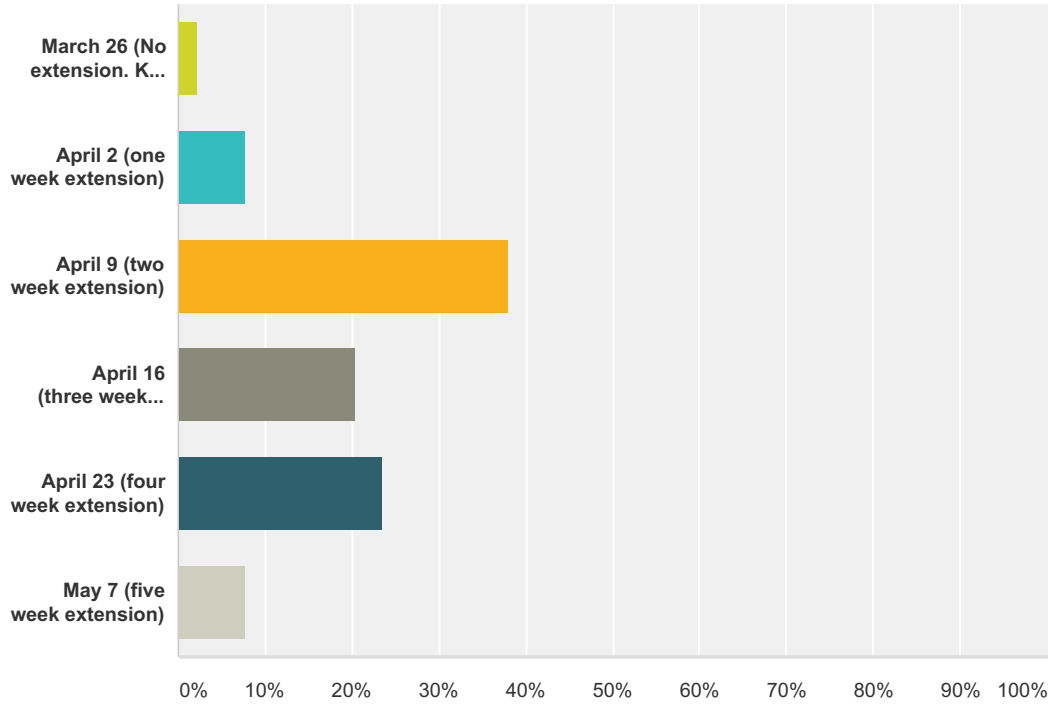

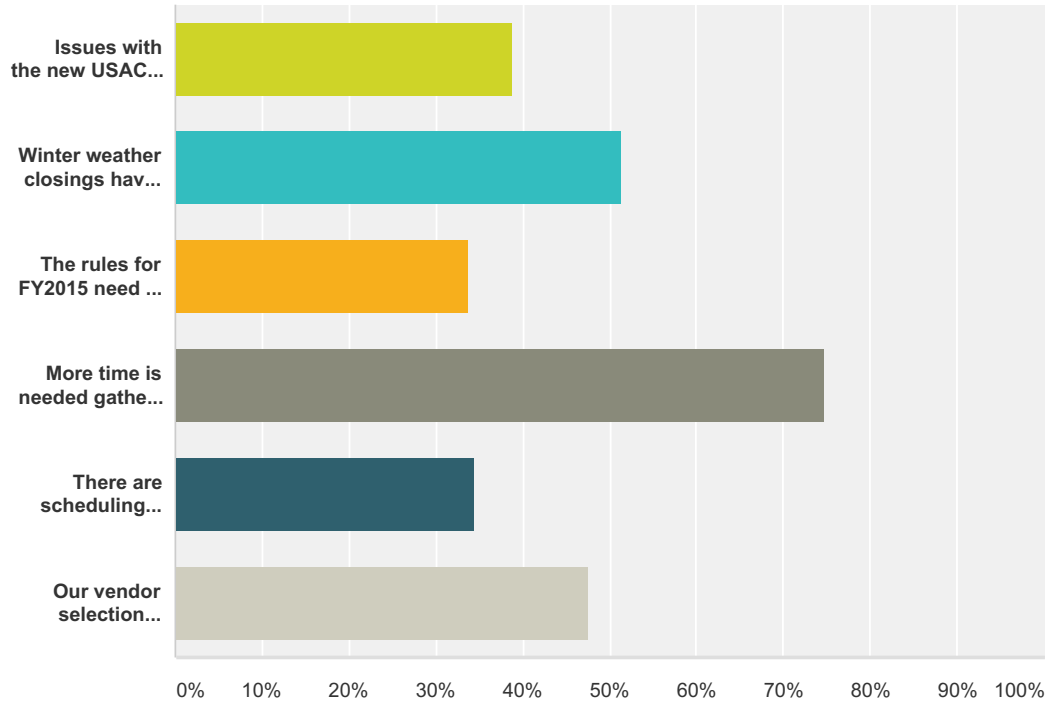
