## STREAMLINED RESOLUTION OF REQUESTS RELATED TO ACTIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

**CC Docket No. 02-6**  
**WC Docket No. 02-60**  
**WC Docket No. 06-122**

Pursuant to our procedure for resolving requests for review, requests for waiver, and petitions for reconsideration of decisions related to actions taken by the Universal Service Administrative Company (USAC) that are consistent with precedent (collectively, Requests), the Wireline Competition Bureau (Bureau) grants, dismisses, or denies the following Requests.<sup>1</sup> The deadline for filing petitions for reconsideration or applications for review concerning the disposition of any of these Requests is 30 days from release of this Public Notice.<sup>2</sup>

In remanding these applications to USAC, we make no finding as to the ultimate eligibility of the services or the petitioners' applications. We also waive sections 54.507(d) and 54.514(a) of the Commission's rules and direct USAC to waive any procedural deadline that might be necessary to effectuate our ruling. *See* 47 CFR § 54.507(d) (requiring non-recurring services to be implemented by September 30 following the close of the funding year); 47 CFR § 54.514(a) (codifying the invoice filing deadline).

Due to a USAC system error, BVCOG could not access an FCC Form 463 to invoice USAC under FRN 16819841 and was notified that the invoice filing deadline was in December 20, 2017 even though the invoice filing deadline was actually December 31, 2019. BVCOG stopped invoicing because it was informed that the invoice filing deadline had lapsed. We deny the waiver request to the extent it seeks an extension of the end date of the funding commitment because BVCOG has not demonstrated special circumstances meriting such a waiver or that such a waiver would be in the public interest. *Request for Waiver by Finger Lakes Community Health on behalf of NY Community Broadband Partnership*, Rural Health Care Universal Service Support Mechanism, WC Docket 02-60, Order, DA 20-264 (rel.
