The group spoke with the commissioner and his staff about modernizing the E-rate program's cybersecurity provisions to ensure that eligible schools and libraries have access to safe and secure high-capacity broadband. The group cited the need to help schools and libraries defend themselves from the growing threat of persistent and harmful cyberattacks, including ransomware attacks, that target school and library networks and sensitive student, teacher, and library patron data.

The attendees called on the Commission to take the following immediate actions to strengthen the E-rate program's cybersecurity provisions:

- 1. Update the program's Eligible Services List for funding year 2022 list to permit Category Two of the program to fully fund firewall devices and services without requiring any cost-allocation.
- 2. Begin the rulemaking that may be required to add more sophisticated cybersecurity protections to the program's investments by inviting public comment on the February 8, 2021, Petition for Rulemaking submitted by the Consortium of School Networking, the State Educational Technology Directors Association (SETDA), the Council of the Great City Schools, the Schools, Health & Libraries Broadband Coalition, the State E-rate Coordinators' Alliance, and the Alliance for Excellence in Education.
