STREAMLINED RESOLUTION OF REQUESTS RELATED TO ACTIONS BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

Pursuant to our procedure for resolving requests for review, requests for waiver, and petitions for reconsideration of decisions related to actions taken by the Universal Service Administrative Company (USAC) that are consistent with precedent (collectively, Requests), the Wireline Competition Bureau (Bureau) grants, dismisses, or denies the following Requests.¹ The deadline for filing petitions for reconsideration or applications for review concerning the disposition of any of these Requests is 30 days from the release date of this Public Notice.²

Parties seeking review of USAC decisions must first file an appeal with USAC. *See* 47 CFR § 54.719(a). Because the petitioner filed its appeal with the Commission first, we now provide the school district 60 days from the release date of this Public Notice to refile its appeal at USAC. Pursuant to the *Little Falls Township Order*, we also waive the 60-day appeal filing deadline, 47 CFR § 54.720(a), to allow the appeals to be considered on the merits by USAC without being considered late. *See Little Falls Township Order*, 38 FCC Rcd at 1104, para. 10. Oregon Community Health Information Network (OCHIN) submitted the reimbursement request to the vendor prior to the FY 2022 invoicing deadline, and due to their vendor experiencing technical difficulties with selecting a new primary account holder, missed the deadline through no-fault of OCHIN. NetFortis Acquisition Co., Inc., ran into issues through no fault of its own with submitting Form 463 by the invoicing filing deadline due to delays associated with a government payments web site. OCHIN states that the service provider had difficulty registering a new primary contact and failed to complete its tasks by the deadline. The service provider for SEMO Health Network – Benton Medical Center received the FCC Form 463 shortly before the deadline and failed to file the form on time. The service provider for Divine Providence received the Form 463 before the deadline but failed to submit the form on time. We waive the petitioners' invoice filing deadlines and allow them 60 days from the release date of this Public Notice to file invoices.
